Town Council Meeting April 1, 2019

Meeting called to order by Mayor Cain at 7:00 P.M. Doug Pierson, Terry Parsons, Leah Higginbotham, and Barbara Reed were present. The Pledge of Allegiance.

Barbara Reed made motion to approve the March minutes as read, Doug Pierson seconded, motion carried unanimously.

Leah Higginbotham made motion to approve payments from March 1st through present date, Terry Parsons seconded, motion carried unanimously.

Chief Will Jordan gave the police report.

Mayor Cain introduced Travis Blankenship, who asked Council if his team would be allowed to use the #4 ballfield for practice. He mentioned that his North Putnam team was primarily made up of kids from Buffalo.

Doug Pierson made a motion to approve Travis Blankenship's request to use the fields, Terry Parsons seconded, motion carried unanimously.

Mayor Cain handed Council an emailed request from Denny Paugh, Assistant Principal of GW Middle School. He is asking Council to waive the usage fees for the use of 2 softball fields during the end of season tournament which will be held from Late April into Early May for about 3-4 days. He stated that the middle school will not directly profit from the tournament, and that the Town could run concessions during the tournament if they choose.

Doug Pierson made motion to approve GW Middle School request to waive field usage fees for the duration of the tournament, Barbara Reed seconded, motion carried unanimously.

Mayor Cain brought up for discussion hiring a part-time town worker to assist the current town employee with the general town maintenance duties. He mentioned that a flyer will be made and posted throughout the town.

Doug Pierson made motion to approve financial statement, Barbara Reed seconded, motion carried unanimously.

Mayor Cain Mentioned that Vandalia agreed to put the pump station in and run sewer at the edge of their property allowing for the possibility to extend town limits to provide sewer for future developments. He said that they also expect to break ground next month.

Mayor Cain mentioned that he is trying to work with the State Attorney General's Office to get ownership of the Town's streets back so we can fix them.

Mayor Cain introduced Travis Blankenship who asked Council that if an owner of a Mexican restaurant would want to come to Buffalo, if they would be able to get an alcohol license. Council told him to tell them to come in and file the necessary paperwork.

Doug Pierson made motion to adjourn, Barbara Reed seconded, meeting adjourned at 7:40 P.M.
