Town Council Meeting April 3, 2023

Meeting called to order by Mayor Cain at 7:00 P.M.

Doug Pierson made motion that we use ARPA money to fund Preliminary Engineering Study for Storm Water Grant, Barbara Reed seconded, motion carried unanimously.

Barbara Reed made motion to approve of the Resolution of the Town of Buffalo Approving Invoices for the Krystal Lane Project, Leah Higginbotham seconded, motion carried unanimously.

Mayor Cain updated Council on the Vandalia Growers sewer-connect. The town is waiting to hear back

Mayor Cain updated Council on the sidewalk grant. The state has release the money to do the preliminary work.

Mayor Cain updated Council on the 2023 Recreational Enhancement Grant application. The town was awarded the money we requested.
