Town Council Meeting
June 4, 2018

Meeting called to order by Mayor Melton at 7:00 P.M.
Alisa Scott, Barbara Reed, Billy Whittington, and Jenny Leighton were present.
The Pledge of Allegiance.

Barbara Reed made motion to approve the May minutes as read, Alisa Scott seconded, motion carried unanimously.

Billy Whittington made motion to approve payments from May 1st through present date, Jenny Leighton seconded, motion carried unanimously.

Mr. LaFon, representing Ms. Pickens, presented his case and evidence to council in regards to the Hearing over a citation enforcing Article 1741.

Mr. Flora, the town attorney, responded with his arguments and evidence to support the citation in regards to Article 1741.

Alisa Scott made motion to enforce the citation regarding Article 1741, Billy Whittington seconded, motion carried unanimously.

Mr. LaFon, representing Buffalo Tire & Brake, presented council with his argument against the B&O Tax assessment and penalties in relation to Article 737.

Mr. Flora, the town attorney, gave his response to council as to the reason for the assessment and penalties along with the methods of how the assessment was calculated.

Alisa Scott made motion to amend assessment to pay the \$795.55 within 30 days before interest will be applied to the total amount, Billy Whittington seconded, motion carried unanimously.

Barbara Reed made motion to approve the "Resolution Authorizing the Submission of a Small Cities Community Development Block Grant Application for the Town of Buffalo, Putnam County, West Virginia", seconded by Alisa Scott, motion carried unanimously.

Mayor Melton handed council the 2016 and 2017 Audit Reports for review.

Barbara Reed made motion to approve Budget Revision #6, Alisa Scott seconded, motion carried unanimously.

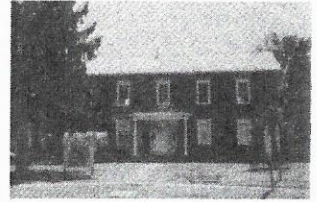
